# **Privacy Policy**

This privacy notice relates to Jackson Cohen Associates Limited of 16 Campions, Loughton, Essex, IG10 2SG and explains about the information we collect about you and the basis on which we control and process it.

### Collecting data – when you make contact

**By Website enquiry** – We will capture your name, email address and the information that you provide in the enquiry form for our legitimate interest and legal purposes and for the performance of any

contract entered into. We will keep a record of this in order to deal with your enquiry and respond accordingly and for statistical analysis of enquiries received and outcomes.

**By phone** - We may use call number identification to recognise who is calling us and to have a short-term record of calls received. We will capture information that you give us for our records and in order to deal with your enquiry and process for our legitimate interest and legal purposes and for the performance of any contract entered into.

**By email** - If you send us an email that is not encrypted any personal data within it may be at risk. We will capture and process the information in the email for our legitimate interest and legal purposes and for the performance of any contract entered into. When we send emails we encrypt some emails or their content in order to protect personal data.

**By post** - When we receive an enquiry or other information from you by post we will capture information that you give us for our records and in order to deal with your enquiry and process for our legitimate interest and legal purposes and for the performance of any contract entered into.

## Providing information to us on other people

# Data we may collect

- your name, address, telephone numbers, email address;

- details of when you contact us and when we contact you (e.g. copies of any correspondence and records of telephone calls); and/or
- details of the work you enquire about, the work we do for you, together with any other
  information (including where obtained from third parties) which we reasonably need to
  operate our business, provide the service you require or fulfil our regulatory obligations.

### **Sensitive Data**

We do not generally seek to capture sensitive data about you. If you have to provide this data we will ask for your permission to do so - e.g. you may advise us of a past criminal record in respect of an application to the FCA for authorisation. We will store this information until the application process is completed. We may hold on to this data for a longer period if you ask us to as a result of an ongoing business relationship.

### Basis of processing data and who we share your data with

We will hold and process your data for our **legitimate interests** in order to:

- To manage business relationships with our professional advisers, contractors and third party providers
- Share information where necessary with funders, our professional advisers, contractors and third party providers and anyone who may wish to acquire all or any part of our business

## **Retaining information**

We will retain information for our legitimate interests and legal purposes as follows:

- Enquiries where no business relationship is formed up to 6 months from the date the enquiry unless there is an indication that the timescale for forming the relationship will take longer
- Professional advisers, contractors and third party advisers up to 6 years from the end of our relationship

## Where we store your data

All information is retained within the EEA. If we were to export any of your data to a non-EEA state we would take appropriate measures to protect the data.

### Your rights
